General Manager Thompson II reported that staff is preparing the documentation requested by the Department of Water Resources (DWR) for the Proposition 1 Integrated Regional Water Management grant funding.

AVEK Assistant General Manager Knudson then stated that staff expects to receive the grant agreement from DWR within 30 days and that an Antelope Valley IRWMP Stakeholders meeting will be scheduled for early October.
