Recommendation:

Palmdale Recycled Water Authority (PRWA) staff recommends adoption of Resolution No. PRWA 2017-001.

Background:

At its January 18, 2017 meeting the PRWA Board directed Authority Counsel to bring back a proposed resolution repealing Resolution No. PRWA 2016-010 which set forth the manner in which Directors of the PRWA could add items for consideration at future Board meetings. The Board felt that the process was too cumbersome and desired that the process be simplified. In addition to repealing Resolution No. PRWA 2016-010, proposed Resolution No. PRWA 2017-001, establishes a method whereby any Board member may make a motion and any member may second that motion and the item will be added to a future agenda with a simple majority voice vote.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION 1. Resolution PRWA 2016-010 is hereby repealed in its entirety.

SECTION 2. To add an item to a future agenda, when the agenda calls for "Requests for New Agenda Items", any member may make a motion to add an item and any member may second that motion and the item will be added via a simple majority voice vote.

SECTION 3. The Secretary of the Board shall certify to the passage and adoption of this Resolution.
