#### 8. REQUESTS FOR NEW AGENDA ITEMS:

Chair Bishop would like to see a public awareness or outreach campaign regarding recycled water and water conservation. Chair Bishop mentioned the possibility of running something in the Palmdale Magazine.

Director Mac Laren spoke regarding possibly getting information out to the public during the upcoming Home & Garden show. She stated that they highlight the use of drought tolerant plants and xeriscaping. She suggested possibly setting up booths or putting together pamphlets with information on water conservation and recycled water.

# 9. INFORMATIONAL REPORT OF THE BOARD OF DIRECTORS, EXECUTIVE DIRECTOR, AND ASSISTANT EXECUTIVE DIRECTOR.

Director Mac Laren asked Assistant Executive Director Heffernan if he had received an invitation to their Ad Hoc meeting. She stated there would be an Ad Hoc meeting for the State Water Contractors next Wednesday from 11:15 a.m. – 2:00 p.m. after their Water Master meeting. Director Mac Laren also stated that in the future they would like to set up a committee consisting of two councilmembers from Palmdale, two councilmembers from Lancaster, a representative from Littlerock, a representative from the Antelope Valley East Kern Water Agency and Director Mac Laren on behalf of Palmdale Water District to create a more regional group to look at ways to use recycled water to help farmers. Assistant Executive Director Heffernan stated he will reach out to Antelope Valley East Kern Water Agency tomorrow.

Assistant Executive Director Heffernan spoke about the status of the Upper Armargosa Creek project. He stated he would like to have a ground breaking event.

Executive Director LaMoreaux and Assistant Executive Director Heffernan met with Donna Termeer and Chris Perry of Supervisor Barger's office regarding the pump station. He stated that the County will work on this and get back to the Board.

Assistant Executive Heffernan stated that due to tariffs we are paying much more in constructions costs. He stated that he will prepare a presentation regarding costs to present to the Board.

Executive Director LaMoreaux stated that every year Palmdale Water District receives a book with a list of tax defaulted properties and that the authority should look for future properties. Two of the properties in this year's list are the southwest corner of 30<sup>th</sup> Street East and Avenue Q, and Avenue R-8 and 60<sup>th</sup> Street East. He stated Palmdale Water District has submitted request for those two (2) properties to use as dispensaries for water.

Assistant Executive Director Heffernan wanted to thank the Palmdale Water District for hosting City of Palmdale staff members Thursday before last and taking them on a tour of the dam and Palmdale Water District facilities.
