Director Dizmang reported that she was unable to attended the Palmdale School District Foundation Dinner held January 31; that on February 6, she attended the Personnel Committee meeting; that also on February 6, she attended a Board briefing with General Manager LaMoreaux regarding tonight's Board Meeting; and that on February 10, she is attending the Palmdale Water District Regular Board meeting.

As Chair of the Personnel Committee, she reported that the Committee reviewed the Engineering Department job descriptions approved earlier this evening, and they developed Committee goals for 2020, which are similar to those of 2019.

Director Wilson reported that on January 8, he attended a Board briefing with General Manager LaMoreaux and Assistant General Manager Ly regarding the January 13 Board Meeting; that on January 9, he attended the Antelope Valley State Water Contractors Association meeting where they paid bills and discussed projects; that on January 16, he attended a CSDA Board Member Liability Issues Webinar; that on January 23, he attended a Board briefing with General Manager LaMoreaux and Assistant General Manager Ly regarding the January 27 Board Meeting; and that on February 6, he attended a Board briefing with General Manager LaMoreaux regarding tonight's Board Meeting.

President Dino reported that on January 29, he attended an Agenda Review and Approval meeting with General Manager LaMoreaux; that on February 6, he attended a Board briefing with General Manager LaMoreaux regarding tonight's Board Meeting; and that on February 10, he is attending the Palmdale Water District Regular Board Meeting.

8.2) Report of General Manager.

General Manager LaMoreaux reported that the Palmdale Fin and Feather Club has been very cooperative regarding the incident at Palmdale Lake last week; that District staff communicated the incident to the State Water Resources Control Board; and that there are no issues with the operation of the Lake resulting from the incident after which Director Mac Laren requested tonight's Board meeting be adjourned in memory of the fisherman who lost his life at Palmdale Lake.

General Manager LaMoreaux then stated that a productive meeting was held last week with the staff of the Palmdale Recycled Water Authority where they discussed the phase II pipeline.

a) Status on the District's Water Tanks. (Assistant General Manager Ly Requested by Director Wilson)

Assistant General Manager Ly provided an overview of the District's water tanks and reservoirs, including the number and type of tanks and total capacity, the age of the reservoirs, maintenance and repairs, internal coatings, regulatory requirements, additional monitoring performed by District staff outside of these requirements, and plans to inspect several tanks with divers, assessing and evaluating tank coatings, and collecting data to perform a conditioning assessment for the tanks followed by discussion of the operations of the clearwell and GAC used at the underground tank.

8.3) Report of General Counsel.

General Counsel Dunn reported that the State Water Resources Control Board has lowered the response testing levels for PFOA's and PFOS's but that the District has no PFOA's or PFOS's in their system.

He then reported that AB 571 involves a campaign contribution limit of \$4,700 from any one source on city and county elected officials and candidates and that this could potentially affect water districts in the future.

RESOLUTION NO. 20-3

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE PALMDALE WATER DISTRICT AMENDING SECTION 8.03(D) OF THE PALMDALE WATER DISTRICT RULES AND REGULATIONS AS IT RELATES TO A FIXED FIRE PROTECTION CHARGE

WHEREAS, pursuant to Water Code Division 11, the Palmdale Water District ("District") is authorized to establish rules and regulations governing the District's operations, accordingly, the District adopted the Palmdale Water District's Rules and Regulations ("Rules and Regulations"); and

WHEREAS, on October 28, 2019, the District's Board of Directors adopted new water rates and charges, including a private fire protection service charge, in compliance with Proposition 218; and

WHEREAS, as a result of the adoption of the new water rates and charges, Section 8.03(D) of the District's Rules and Regulations is now outdated; and

WHEREAS, the District does not wish to adopt a new charge or fee, nor increase the existing charge or fee through this action; and

WHEREAS, the District desires to update the District's Rules and Regulations to ensure consistency with the District's newly adopted water rates and charges.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Directors of the Palmdale Water District as follows:

Section 1. The above recitals are all true and correct and hereby adopted as findings.

Section 2. The Board of Directors hereby amends Section 8.03(D), Rates for Compound Meters Sizes for Fire Protection, of the Palmdale Water District Rules and Regulations to read, in its entirety, as follows:

"D. Rates for Compound Meters Sized for Fire Protection:

Effective March 1, 1998, compound meters which are sized for fire protection and used primarily for providing domestic and/or industrial water will be charged using the middle register for meters containing three registers, or by using the smallest register for meters containing two registers as the base for the minimum monthly charge. In addition to the above, there will be a flat rate charge in an amount, adopted and set forth by resolution from time to time, for standby pressures and quantities of water for fire protection and to cover the costs of maintenance, repair, and testing of the meter and appurtenances. For example, an 8" x 4" x 2" compound

meter will be assessed its minimum bill on the four-inch register and an 8" x 2" compound meter will be assessed its minimum bill on the two-inch register. If any usage is registered on the large component register for any given month, the standard rate for billing for that size meter will be charged plus the standard rate for amounts of water used above the volume allowable per said minimum monthly charge. In addition, the District will check said compound meters for accuracy at least once, and preferably twice, a year."

Section 3. Upon the effective date of this Resolution, adopted herein, the Resolution shall supersede any and all prior resolutions adopted that are in conflict with this Resolution.

Section 4. If any provision in this Resolution, or the application thereof to any person or circumstances, is for any reason held invalid, the validity of the remainder of this Resolution, or the application of such provisions to other persons or circumstances shall not be affected thereby. The Board of Directors hereby declares that it would have passed this Resolution, and each provision thereof, irrespective of the fact that one or more sections, subsections, sentences, clauses or phrases or the application thereof to any person or circumstance be held invalid.

Section 5. This Resolution shall become effective upon the date of adoption as set forth herein.
