# MINUTES OF REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE PALMDALE WATER DISTRICT, AUGUST 26, 2019:

# 7.1) Consideration and Possible Action on Appeal From Samerah Plawan to General Manager Determination Regarding Application of Outstanding Charges From 1552 High Point Drive, Palmdale. (General Manager LaMoreaux)

After a brief discussion of Mr. Plawan's admitted repeated illegal use of water and of General Manager LaMoreaux's determination to waive fees associated with this use, it was moved by Director Wilson, seconded by Director Dizmang, and unanimously carried by all members of the Board of Directors present at the meeting to deny the appeal received from Samerah Plawan upholding the General Manager's determination regarding the application of outstanding charges from 1552 High Point Drive, Palmdale.

#### 9) Board Members' Requests for Future Agenda Items.

After clarification of Notification Levels, Public Health Goals, and Maximum Contaminant Levels for treating water, Director Alvarado requested an item be placed on the next agenda for "Consideration and possible action on security of fencing bordering the Palmdale Fin and Feather Club and the Avenue S park and ride."

Director Dizmang then thanked Antelope Valley Press reporter Alison Gatlin for the informational article on the District's Water Rate Study.
