7.5) Consideration and Possible Action to Approve an Extension of Milestones and Minimum Usage, or Payment, Contained in County Sanitation District Contract No. 5001 with Palmdale Water District and Authorize General Manager LaMoreaux to Finalize and Execute Said Extension. (No Budget Impact – General Manager LaMoreaux)

General Manager LaMoreaux provided an overview of the extension to County Sanitation District Contract No. 5001, and after a brief discussion of the benefit of extending this contract, it was moved by Director Alvarado, seconded by Director Dizmang, and unanimously carried by all members of the Board of Directors present at the meeting to approve an extension of milestones and minimum usage, or payment,

contained in County Sanitation District Contract No. 5001 with Palmdale Water District and to authorize General Manager LaMoreaux to finalize and execute said extension.

### 8.1) Reports of Directors:

Director Alvarado reported that on August 29, he attended required AB 1825 sexual harassment training; that on September 12, he attended the Antelope Valley State Water Contractors Association meeting; that on September 17, he attended the Regional Leadership and Outreach Committee meeting; that on September 18, he attended the employee all-hands luncheon with Director Mac Laren; that on September 19, he attended the funeral services for former Palmdale Water District Director Wayne Hoffmeyer; that also on September 19, he attended a Board briefing with General Manager LaMoreaux and Assistant General Manager Ly regarding tonight's Board Meeting; and that on September 20, he attended the ACWA Region 8 Legislative Forum.

As Acting Chair, he then reported that at the September 17 Regional Leadership and Outreach Committee meeting, the members attending were Alternate Committee Member Dino and himself; the Committee considered the Legislative Advocacy Policy approved earlier this evening where the Committee agreed the Policy is needed to support or oppose legislation in a timely manner and recommended its approval to the full Board; and the Committee was updated on and concurred with outreach activities for 2019, including the issuance of press releases, regional leadership supporting events, and various Proposition 218 water rate revenue increase activities.

He then provided a detailed report on specific items discussed at the ACWA Region 8 Legislative Forum as outlined on the Director Meeting Report Form hereby made a portion of the minutes of this meeting.

Director Mac Laren reported that on September 11, she attended a meeting with Dr. Mathis and President Dino to review ideas for the direction of the District, and Dr. Mathis will be scheduling dates to meet with other Directors; that on September 16, she attended the Antelope Valley Watermaster Public Water Supplier meeting via telephone; that on September 18, she attended the employee all-hands luncheon with Director Alvarado; that on September 19, she attended the Organizational Excellence

Committee meeting; and that also on September 19, she attended a Board briefing with General Manager LaMoreaux and Assistant General Manager Ly regarding tonight's Board Meeting.

Director Dizmang reported that on September 12, she attended required AB 1825 sexual harassment training; that on September 19, she attended the Organizational Excellence Committee meeting; and that also on September 19, she attended a Board briefing with General Manager LaMoreaux and Assistant General Manager Ly regarding tonight's Board Meeting.

As Chair, she then reported that at the September 19 Organizational Excellence Committee meeting, the members attending were Committee Member Mac Laren and herself; the Committee considered and approved Diversity and Inclusion Training for staff scheduled for December 12 and reviewed the qualifications of the speaker for this training; the Committee concurred with maintaining the District's current benefits package and policy; and the Committee was informed that the District has been approved for the District Transparency Certificate of Excellence.

Director Wilson reported that on September 5, he attended a Board briefing with General Manager LaMoreaux and Assistant General Manager Ly regarding the September 9 Regular Board Meeting; that on September 7, he attended the Open House at the Leslie O. Carter Water Treatment Plant regarding the 2019 Water Rate Study; that on September 10, he attended his Coffee with a Director event; that on September 17, he attended the Regional Leadership and Outreach Committee meeting; and that on September 19, he attended a Board briefing with General Manager LaMoreaux and Assistant General Manager Ly regarding tonight's Board Meeting.

President Dino reported that on September 10, he attended an AVEK Board Meeting; that on September 11, he attended a meeting with Dr. Mathis and Director Mac Laren; that on September 12, he attended the Antelope Valley State Water Contractors Association meeting; that on September 17, he attended the Regional Leadership and Outreach Committee meeting filling in as an alternate for Director Wilson; that on September 19, he attended a Board briefing with General Manager LaMoreaux and Assistant General Manager Ly regarding tonight's Board Meeting; that on September 20, he attended the Los Angeles County Sanitation District meeting; that on September 23, he is attending the Palmdale Water District Board Meeting; and that
